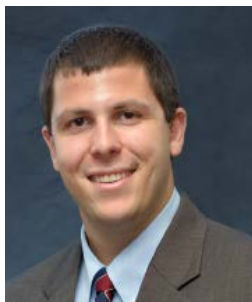

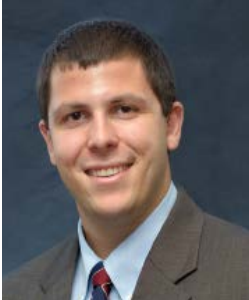
Several representative engagements Ross has worked on since joining GlassRatner include:
