Dan Korczyk is a CPA with specific certifications in Financial Forensics and Valuation. He has practiced as a consultant and expert for more than 25 years. Dan's experience includes time spent in Public Accounting and Corporate Finance, where he served more than seven years in various senior leadership roles at a Fortune 100 company, including Director of Mergers and Acquisitions, and several subsidiary-level CFO positions. #### Bankruptcy/Restructuring

- On behalf of the SEC, Dan led 50 professionals in the forensic restatement of WorldCom's financial statements—monthly, over 10 years. He reported directly to former SEC Chairman, Richard Breeden. Dan's findings were directly related to the widely-publicized \$80 billion write down taken by WorldCom, above and beyond the accounting irregularities reported at the outset of the WorldCom fraud matter.
- Related to claims set forth by the Trustee in a bankruptcy of a healthcare insurance company, Dan prepared an extensive solvency analysis to demonstrate that a defendant properly exercised its right to redeem its minority shareholdings, two years earlier, in the amount of approximately \$30 million without contributing to the later insolvency of the business.
- Two globally recognized private equity firms took ownership of a large European telecommunications company, leveraged the business, and distributed the creditors proceeds as dividends to their own benefit. Shortly thereafter, the business entered bankruptcy. Dan prepared detailed financial analysis to demonstrate fraudulent conveyance.
